We would like to inform that, M/s RPCL has obtained the EC from MoEFCC on 30/01/2023 vide EC identification no EC23A008KA163015 and CFE from Karnataka State Pollution Control Board vide no CTE-336285 dated 17/02/2023. At present the project is under construction stage, the construction work was started from 2nd May 2023. Hence EC conditions were applicable from February 2023, most of the EC conditions were not applicable in the reporting period i.e September 2022 to March 2023, however the Environment Management Plan will be implemented along with project.


